The biggest thing is help, we have over 300 members and hopefully we will have more members help out.

Marilyn Miller on Farewell Car Show/Picnic: Spring Picnic will be April 3<sup>rd</sup> at Mountain View and we have a sign-up sheet going around so we can get an approximate head count. The club is providing coffee, lemonade, ice tea and water and table service. There's no refrigeration but there are plenty of plugs for crockpots.
