### **Old Business**

Troy asked Yvonne to read last month's motion regarding club membership dues. Yvonne said last month Lloyd Hildebrandt made a motion seconded by Walter Peterson to change the dues to \$25 and to include the second member in the household. She noted that Jo had requested that we find out what this would cost the club.

Troy asked Roxie what she found out: Roxie said it will cost us about \$800. Troy asked if there was any discussion on this motion. He said it would go into effect in 2020 if we change it.

Gary Davis said it's a numbers game and that would be a way to raise our numbers. He said this is what RCSC looks at.

The motion failed and dues will stay the same.

### **New Business**

He will write the report and present it at the January meeting. Troy asked for volunteers and Bill Senter volunteered to help Ed.

Gary Meager asked for help on his Nova and also told everyone he could answer most questions regarding car repairs for others.

Denny Lockman reported on the Anniversary Party at Fairway January 12<sup>th</sup>, cost is \$20 and includes good food and entertainment. Denny will take your reservations today.

Troy reported new shop hours are Monday – Thursday 8-4 and Friday 8-Noon. The more monitors we get the longer we can be open.
